This Bulletin provides a summary of procedures recently introduced.

# **Employer Services Procedures**

Effective September 6, 2018, 23 new procedures were approved to formally document processes and guidelines for Assessment Services.

The procedures are classified within the six subject areas outlined below:

## 100.00 Coverage

101.00 Coverage under the Workplace Health, Safety and Compensation Act

102.00 Independent Operator Determination

103.00 Optional Personal Coverage and Householder Coverage

104.00 Out of Province Coverage

Coverage procedures outline requirements to register with WorkplaceNL, as well as the terms and conditions for optional forms of coverage for situations where registration is not mandatory.

#### 200.00 Registration

201.00 Employer Registration

202.00 Assignment of New Firm Numbers

204.00 Authorized Representative

Registration procedures detail the registration application process in general, as well as registration for prior years and for operations outside of Newfoundland and Labrador. Cancellation of coverage, the assignment of firm numbers, changes in business structure and how an employer can designate authorized representatives on their WorkplaceNL account(s) are also explained.

### 300.00 Classification

301.00 Employer Classification

This procedure is an administrative guideline supporting Policy ES-03, Classification of Employer's Operations. It explains how WorkplaceNL uses the Newfoundland Industrial Classification System to classify employers by industry with corresponding assessment rates.

Assessment procedures for special considerations explain reporting requirements and how to determine assessable earnings within all industries, with information about the differences that exist for employers in certain industries.

These procedures cover all aspects of how we collect assessments due from employers, including:

- payment terms, options and plans;
- legal action;
- obligations of company directors;
- change of business ownership and successorship; the impact of missed payments on clearance; and
- refunds and credit write-offs.

### 700.00 Auditing (Financial)

#### 701.00 Assessment Audits

This procedure outlines the authority of WorkplaceNL under the Workplace Health, Safety and Compensation Act to collect information to determine if an employer is correctly classified and accurately reporting payroll. Topics covered include:

- explanation of how employers are selected to be audited;
- information that an auditor may need;
- audit process; and
- audit results.
